2003 to Date: Senior Actuary of Actuaries for Lawyers Ltd

Actuaries for Lawyers Ltd was set up to provide actuarial services to solicitors in 2003 at a time when the predecessor company decided to withdraw from the market. David was asked to head this up as Senior Actuary.

In Autumn 2004, Actuaries for Lawyers Ltd joined with Pension Actuaries Ltd, an existing firm of consulting actuaries set up by fellow actuary Paul Windle. Both firms subsequently trade as "Actuaries for Lawyers" and provide pension and actuarial services to solicitors, barristers and individual clients.

"Actuaries for Lawyers" is consulted on over 1,000 matrimonial cases, 50 personal injury and employment cases and 20 Trust valuation cases (life interests) per year.

David continues to be involved in trying to assist solicitors in occupational pensions matters and to provide information and Reports for solicitors and Courts throughout the UK on actuarial matters relevant to the legal profession.

Actuaries for Lawyers is dedicated to providing information that is unbiased and understandable to the legal profession and its' clients. The company runs seminars for solicitors throughout the country and these are well attended and very well received.

David has been a guest speaker at seminars run by Resolution and by several barristers' chambers as well as speaking at the "Unlocking Pension Rights in Divorce" seminars run by Jordans in 2008, 2009 and 2010, at the "Pensions on Divorce" seminar run by Jordans in 2010, 2011 and 2012 and at the "Ancillary Relief Update Conference 2008" by Central Law Training Ltd.

David has given a number of talks at the Judicial College in 2010 and 2012.

David also contributed significantly to the 2007 publication "Unlocking Matrimonial Assets on Divorce" (reprinted in 2009 and 2012) and is co author of the 2008 publication "Pensions and Divorce" along with Edward Hess (His

Honour Judge Hess) and Fiona Hay (Recorder and barrister at Harcourt Chambers), with second and third editions published in 2012 and 2017.

David also appears on the College of Law's Legal Network Television training DVDs speaking about pensions on divorce.

David was also part of the Pensions Advisory Group and one of only two people who attended every official meeting.

David now has 34 years experience in pensions, of which 31 years' has been in occupational pensions and has been working exclusively on pensions advice for solicitors for 21 years.

David has acted as expert witness to Courts and tribunals on many occasions and given expert evidence regularly in Court, attending Court on average approximately six times per year. David was consulted as actuary in the Court of Appeal in the case of *Martin-Dye* in 2006.

David is a member of the Expert Witness Institute.

2001 to 2003: Consulting Actuary at Brinkworth Actuarial Services Limited

In addition to being a Consulting Actuary, David developed the procedures and operations manual and also ran the Brinkworth Actuarial Services Limited/Hazell Carr Work Centre in Wiltshire.

David gave over 100 seminars to groups of solicitors and IFAs as well as doing most of the training for Hazell Carr in this field.
